FIRE DEPARTMENT SAFETY ADVICE AND RECOMMENDATIONS:

- It is recommended to have chimneys cleaned and inspected at least once per year by a professional.
- Ensure there is no debris and clutter around or on your wood stove and heaters. Wrapping paper and cardboard should not be burned in a wood stove.
- Ensure all smoke and carbon monoxide detectors are working properly.
- Dispose of wood ashes in a metal container and do not set them on the porch or near the house.

Mud Season Notice: The Town of St. George is advising Town Residents and Community Members to be cautious as the early mud season is upon us. It is not recommended to drive through deep ruts and mud as it can cause further damage to the road or your vehicle. ANIMAL REGISTRATION & ANIMAL CONTROL

Animal Registration Update and Reminder: There are currently 49 dogs registered in the Town of St. George. Registration is due annually on April 1 and current rabies vaccination is required. Please note registration after April 1 will result in increased registration fees. Please contact Amanda Vincent, Town Clerk, at townclerk@stgeorgevt.com with any questions.

Dog Ordinance: Jeffrey Wells, Animal Control Officer; Justin Mason, Assistant to the Town Boards; Amanda Vincent, Town Clerk; and the Selectboard will be working on the dog ordinances and policies for the Town of St. George with assistance from Vermont League of Cities and Towns. The ACO and Selectboard advise keeping your animals on your property, with either a leash or contained inside of a fence and always having your animals up to date on rabies vaccinations. The Town of St. George Selectboard **discussed** CVU Vote and Community Loss, Ayer Road, Town Financials, Grants, Dog Update, St. George Policies, St. George Newsletter, Assessor Interlocal Agreement Meeting, Road Consultant, Green Up Day, and Next Planning Commission Meeting. **Action taken** includes Consent Agenda, Town Financial Policies, Declaration of Inclusivity, CSWD Budget, and Planning Commission Member Appointment at the April 18, 2024, Regular Meeting. The St. George Selectboard discussed VCDP Grant Presentation **Action taken** includes Resolution Vote and ADA Assessment Proposal at the April 4, 2024, Special Meeting. **There is (1) vacancy on the Selectboard.**

The Town of St. George Planning Commission discussed the Organization of the Planning Commission, Rules of Procedure, Ayer Road and Willow Brook Lane, Town Board Meeting Minutes, Town Plan Updates, and the Next Planning Commission Meeting Date at the April 24, 2024, Planning Commission Meeting. **Planning Commission members are needed.**

The Town of St. George Cemetery Commission **discussed** Fence Repair Update, Stonework Update, Spring Cleanup (volunteers needed), VLCT Open Meeting Law Training Report, and Cemetery Boundary Lines. **Action taken** includes setting the date for Spring Cleanup of June 22, 2024, from 9:00am – 1:00pm at the April 22, 2024, Cemetery Commission Meeting.

- Community Project title: Dorothy Alling Memorial Library Weatherization, Electrical, Internet Access & Future Planning Project. This is a multi-faceted renovation project which includes a weatherization initiative to replace windows, exterior insulation and siding, electrical upgrades to replace current fluorescent lighting with LED lighting and, installation of a new electrical service. The project includes plans for improving internet access and privacy for patrons to use the internet, by installing a privacy pod and upgrading the Wi-Fi network used to support internet access.
